The Malta Financial Services Authority (“MFSA” or “the Authority”) has become aware of an entity operating under the name of **Advent Trading Limited** which has an internet presence at <https://adventtradingltd.com/> however, the website is currently offline. This website is using the details of a Maltese Registered Company, Advent Trading Limited (C 49576), which does not offer financial services. Fraudsters are using the details of this genuine company in an effort to deceive the public.

The MFSA wishes to alert the public, in Malta and abroad, that <https://adventtradingltd.com/> is **NOT** a Maltese registered Company **NOR** licensed or otherwise authorised by the MFSA to provide any investment services or any other financial services which are required to be licensed or otherwise authorised under Maltese law. Additionally, the Authority confirms that <https://adventtradingltd.com/> has **NO** association with the Maltese registered company Advent Trading Limited (C 49576).

The website <https://adventtradingltd.com/> therefore appears to be a **clone** of the legitimate entity and the public should therefore refrain from undertaking any business or transaction with the false entity.

Id-dettalji ta' din il-kumpanija ġenwina qed jintużaw minn frodisti sabiex iqarrqu bil-pubbliku.
