

Financial Services Register



The Malta Financial Services Authority ("MFSA" or "the Authority") has become aware of an entity operating under the name of Arb Signals Ltd which has an internet presence at https://arbitly.io/. Arb Signals Ltd claims to be an "Arbitrage Trading Platform with aim to get rid of the remarkable market problems that have lingered for long in the crypto exchanges…"

The Authority would like to inform the public in Malta and abroad, that Arb Signals Ltd is **NOT** a Maltese registered Company **NOR** licensed or otherwise authorised by the MFSA to provide any VFA related services or any other financial services which are required to be licensed or otherwise authorised under Maltese law.

The MFSA would like to remind consumers of financial services not to enter into any financial services transaction unless they have ascertained that the entity with whom the transaction is being made is authorised to provide such services by the MFSA or another reputable financial services regulator. Financial regulations obliges licensed businesses to comply with strict legal requirements in the interest of investors and the markets. The activities of unlicensed entities are unregulated making transactions with such entities risky for consumers.
