Lisboa, 23 de Março de 2021: Nos termos e para os efeitos do disposto nos artigos 17º e 244º do Código dos Valores Mobiliários e do Regulamento n.º 5/2008 da CMVM, a EDP – Energias de Portugal, S.A. (EDP) vem prestar a seguinte informação ao mercado:

No dia 17 de Março de 2021, a AllianceBernstein L.P. (“AllianceBernstein”) comunicou à EDP, nos termos do artigo 16.º do Código dos Valores Mobiliários, que detém uma participação qualificada de 1,96% do capital social e dos direitos de voto da EDP. A redução do patamar de 2% pela AllianceBernstein ocorreu no dia 12 de Março de 2021.
