Dear Sirs,

We hereby communicate a reduction of qualified holding, pursuant to article 16/2 b) of the Securities Code, approved by Decree-Law no. 486/99, of 13th November, and republished by Decree-Law 357-A / 2007, of 31 October.

Thus, we hereby communicate the following:

- a) As from 25th October 2021, Fundo Santander Small Caps España holds 620,154 shares, corresponding to **1.9749%** of the share capital, relating to **1.9749%** of the voting rights. In total, the securities investment funds managed by Santander Asset Management S.G.I.I.C., SA, hold 620,154 shares, corresponding to **1.9749%** of the share capital, relative to **1.9749%** of voting rights, thus reducing their participation to less than 2% of qualified holding.
- b) The reduction of qualified holding took place on 25th of October 2021.
- c) The reduction of the qualified holding occurred through the sale on the market of 25,994 shares by Fundo Santander Small Caps España on 25th of October 2021.

We also inform you that we have sent a copy of this communication to the market supervision entity, the Securities Market Commission.
