# MANAGEMENT TRANSACTION RELATED TO FLICKA FLORESTAL, S.L. ACQUISITION OF SHARES

**Lisbon, February 23<sup>rd</sup>, 2022:** Pursuant to and for the purposes of Article 19 of Regulation (EU) No. 596/2014 of the European Parliament and of the Council, of Delegated Regulation (EU) No. 2016/522 of the Commission and in Article 29- R of the Securities Code, EDP - Energias de Portugal, S.A. ("EDP") provides the following information to the market and to the public in general.
