

MOTA-ENGIL INFORMS ABOUT SHARES TRANSACTIONS BY PERSONS DISCHARGING MANAGERIAL RESPONSIBILITIES

Pursuant to the purposes of CMVM Regulation nº 5/2008, republished by the CMVM Regulation nº7/2018, in particular its Article 14, we inform that we have received from Mr. António Manuel Queirós Vasconcelos da Mota, President of the Board of Directors of Mota-Engil, SGPS, S.A. and therefore considered a person discharging managerial responsibilities under the paragraph 3 of Article 248-B of the Portuguese Securities Code, the following communications of shares transactions:

After these transactions, Mr. António Manuel Queirós Vasconcelos da Mota became the holder of 1,500,000 shares of Mota-Engil, SGPS, S.A., corresponding to 0.49% of its share capital, and the number of shares of Mota-Engil, SGPS, S.A. attributable to FM – Sociedade de Controlo, SGPS, S.A. arise to 123,154,352, corresponding to 40.14% of its share capital.
